A MESSAGE FROM THE INTERIM CHAIR

It is with great pride that I present the 2021 European Rugby League (ERL) Annual Report. As the world and the sport of Rugby League emerged at different rates from the global pandemic, we saw a gradual return to normality across the game and we hope that by 2022 all of our members will have been able to resumed activity without COVID restrictions.



Reflecting on 2021, it is of course with great sadness that I write this introduction, due to the passing in August, of our late Chairman, Maurice Watkins CBE. Maurice provided great experience to our organisation in the Chair role, which he held from 2012.

Maurice's reputation in the sport's world was high and having him as our chair brought us credibility and the ability to develop new partnerships. His strong legal career provided great guidance on many matters, governance was another key area he led on. All our general managers benefited from his wisdom and mentoring, which was always delivered in such a supportive manner and his board colleagues enjoyed the same and appreciated his kindness and the generosity of time he gave to everyone. Maurice will be remembered as a great servant to European Rugby League and is very much missed by us all.

The decision for France to host the 2025 World Cup was a momentous appointment. I congratulate Luc Lacoste and his FFR X111 colleagues on this success and will fully support them over the journey to the return of our World Cup to its original location in 1954.

Although we were disappointed to see the postponement of the 2021 Rugby League World Cup, Europe led the world in the return to playing international games as Serbia took the Euro B title in Belgrade in early October, before the Netherlands claimed the Euro D title in Bodrum shortly afterwards, both teams demonstrating huge progress after investing resources into growing their domestic competitions which has in turn translated into international success. Our congratulations and thanks to the two hosting countries as well.

We were also thrilled to see an array of bilateral fixtures in the men's, women's and wheelchair games taking place in the Autumn, which demonstrates the continued passion in the northern hemisphere for the international game.

Off the field European Rugby League broke new ground by becoming the first sports governing body in the world to receive a governance rating from the Sports Integrity Global Alliance. ERL was awarded a silver rating on the SIGA Independent Rating & Verification System (SIRVS) which was the result of a comprehensive series of audits and corrective action plans over a six-month period. We will continue

to work with SIGA to monitor our performance against the framework and deliver against their recommendations to achieve an improved rating in the future.

Alongside the SIRVS programme the organisation concluded a governance review, informed by our

wider membership and with a focused governance working group made up of members from different

classes of membership with the proposed changes being voted through at our AGM in November. The

collaborative process, including members, was an important facet, which once again showed the care

about and camaraderie across our Federation. The Board and the executive will continue to develop

and deliver against these changes throughout 2022.

European Rugby League is fortunate to be supported by some fantastic volunteers who give their time

freely to support our paid staff structure with expertise and time to help us to achieve our objectives.

Phil Caplan (Media Manager), George Stilianos (Social Media Manager), James Vukmirovic

(Webmaster), Martin Crick (Coaching Manager) and Tom Mather (Match Officials Manager) are

essential cogs in our engine and their contributions make a huge difference to our members.

I would also like to thank our staff, David Butler, Jovan Vujosevic, Remond Safi, Romeo Monteith and

Nigel Hansford for their ongoing efforts. They are hardworking and care deeply about the work they do,

I would also like to thank my Board colleagues for their diligent work on behalf of the Confederation.

Finally, I would like to pay tribute to the members of European Rugby League who, for a second COVID

year, have persevered in the face of adversity with their efforts to grow this great game of ours. It has

been a trying time for your clubs, coaches, match officials and colleagues but the game is returning and

demonstrating the appetite for it across the Northern Hemisphere. We look forward to the postponed

World Cup in 2022 and the qualification journey to the 2025 which many of you will be involved in. There

is plenty to be invigorated about and we look forward to supporting you with your aspirations.

GENERAL MANAGER

Joining European Rugby League in January 2021 was a challenging time with Coronavirus restrictions in place for many of our members and sport being on hold in many countries. Sadly, we had to take an early decision to cancel the Euro C competition and for the second year running the U19s Championships, however we were able to stage Euro B and Euro D and with some changes to the formats and hosting the competitions in one place to reduce the exposure to risk, we presented two excellent international tournaments.



One of my first jobs in post was to finalise the organisation's strategy, something European Rugby League had been without for a few years. With a direction of travel and an accompanying operational plan to measure our progress, all staff now have clear annual objectives to allow us to deliver our strategy and focus our resources accordingly.

Working through the SIGA Independent Rating & Verification System gave a valuable insight into the workings of the company and with the support of the governance working group and insight gained from the member survey we were able to identify several areas of reform which were voted through at the AGM and led to us being awarded a silver rating by SIGA and we will continue to embed the proposed changes to maintain both our rating and our strategic objective of being the leading confederation in global Rugby League.

Additionally, the SIRVS process allowed us to review several policies and processes and review a lot of internal documentation which was time well spent the unusual circumstances preventing activity in the opening half of the year.

Looking ahead to 2022, we can plan with more certainty for competition to return and we intend to expand our official competition portfolio to stage a Women's European Championships, to stage the Youth European Championships in Italy at the third time of asking and to begin the 2025 Rugby League World Cup qualifying journey in the MEA region with the MEA Championships and to recommence supporting our members with their technical education to increase the number of coaches and match officials globally and improve the sustainability of technical education by qualifying more educators.

EUROPE REGIONAL DIRECTOR

After the impact of the Chovid-19 pandemic in 2020, that left great consequences on the whole sport in Europe, as well as rugby league, in 2021, there has been a revival of domestic and international activities in Europe and many countries returned to play.

Nations such as England and France have successfully delivered professional leagues, while Wales, Scotland, Ireland, Norway, Czech Republic, Malta, Serbia, Greece and Ukraine have successfully organized amateur full 13-side competitions. Some countries, such as Germany, were not able to hold domestic competitions due to restrictions on the pandemic.



In second part of 2021 ERL manage to deliver return of official competitions after two years. European Championship B and D were successfully organized in Belgrade, Serbia and Bodrum, Turkey. Both competitions were delivered in "balloon" fallowing all Covid-19 local measures to protect all players and staff involved. Serbia, Ukraine and Russia took part in European Championship B, while the Netherlands, Czech Republic, Turkey and Malta took part in European Championship D. Serbia won European Championship B and Netherlands won European Championship D.

What is encouraging is the return of the women's and wheelchairs rugby league to international scene. England, France, Wales, Ireland and Scotland have successfully realized wheelchair rugby league competitions and test matches, while England, France, Ireland and Wales have realized international women's matches.

The European Rugby League family has become richer for another member, Montenegro, while contacts have been made with Slovakia, Northern Macedonia, Belarus, Georgia, Austria and Croatia. Slovakia and Northern Macedonia have registered a legal entity in their countries and both countries are in the process of applying for observer membership.

MEA REGIONAL DIRECTOR

The MEA Region has shown further growth despite the pandemic and continues to implement the roadmap to forming an independent confederation.

The MEA Steering Committee appointed its new extended board for the next 12 months with representatives from the two full members, Dr Frans Erasmus (South Africa) and Nayef Abi Said (Lebanon), plus elected Affiliate member representative Adam Sadder (Nigeria) and Observer member representative Ghassan Badawi (Libya). Three independent members have also been added



to the extend committee with Sami Garebedian (Chair), Bolu Fagborun, Saad Boujmal. Remond Safi has been appointed as Secretary of the Steering committee. A sub.committee has been established to develop the region's first strategy.

MEA welcomed back South Africa who has realigned to the region from APRL. MEA nations are expressing a growing desire for more input in the future of the game which demonstrates their growing capacity and confidence. The region welcomed its newest member Kenya Rugby League Federation after lengthy process which ensured strong governance around its constitution, its members obtaining local sports law recognition, which will further stabilize the organisation.

South Africa and Libya (in Arabic) completed an online technical L1 coaching education.

Ghana demonstrated the type of innovation that permeates this exciting region by partnering with Salford red devils with plan to have player pathways to Salford and establishing academies to be led by Ghana coaches.

Local championships were completed by Lebanon, Ghana (women, men and youth), whilst Nigeria, Cameroon, Burundi and South Africa seasons conclude in 2022. Looking ahead to the world cup, Lebanon are looking to include a record number of local players which recognises their efforts locally.

AMERICAS REGIONAL DIRECTOR

2021 began with the formation of the Americas Steering Committee (ASC), tasked with providing the region towards eventual Confederation status. Each regional IRL member country has a representative on the Committee.

The region welcomed El Salvador as its newest member after European Rugby League and the IRL ratified their Observer application mid-year. Their admittance is a historic first for a country from Central America.



There were Technical Education activities were delivered in the USA, as that country continue to grow its ranks of level 1 candidates.

In North America, both Canada and the USA were able to execute domestic men's championships. However, there were growing concerns for the game in the US, as several teams on the East Coast withdrew from the National competition for varying reasons. Neither team were able to play internationals as Covid played havoc with international travel. Jamaica was again stymied in its efforts to play any Rugby League as government restrictions prevented play. They did manage to play a full international against Scotland.

Though the year began with Canada, USA, and Jamaica undertaking major planning and expenditure as they prepared for the RLWC21, the tournament was postponed to 2022 and this had significant impact on the local volunteer administrators and finances and work continues to support them ahead of the 2022 tournament.

COACHING MANAGER

The Covid pandemic once again impacted heavily upon coach education activity throughout all regions under the ERL banner. Travel between countries was once more almost impossible, so I was unable to conduct any training with either coaches or educators on the ground. However, there were some encouraging developments in spite of this, particularly in the Middle East and Africa region.

Most significant was the re-emergence of South Africa as a force within MEA. Previous attempts to develop coach education there have been largely unsuccessful, but under a new regime SARL



seems to be much more dynamic and proactive. Three coaches with considerable experience have been trained as Level 1 educators. Nico Serfontein has previous RL experience in the United Kingdom, working with Hemel Hempstead; Jean Coetzer is a qualified NRL coach; and Fanie Bredenham has vast experience in rugby union plus is the current National Coach for SARL. Under my supervision a very successful Level 1 course was held via zoom. Practical sessions and assessments will be delivered once Covid regulations permit and therefore we should see the first properly qualified SARL coaches early in 2022.

A L1 course via zoom was also delivered in Ghana, although several the coaches had very intermittent wi-fi reception, which hampered the delivery somewhat. Ghana RL has been very active this year and have organised a number of training courses for both coaches and match officials. They have established a link with Salford Red Devils which hopefully will prove fruitful not just in logistical terms but in furthering their knowledge of Rugby League. The MEA region also saw a historic first with a zoom course in Arabic in Libya, delivered by Gaby Haddad from Lebanon. However, the difficulty, as so often, is the inability to follow up with the practical elements of the course as there is no coach educator in Libya and their knowledge of the fundamentals of Rugby League is limited. Once travel becomes easier a priority must be to follow up on these new developments with coach educator visits.

Elsewhere Mike Brogan was able to continue his work in the USA, holding Level 1 courses in California and Chicago. The latter was highly significant in that it was hosted by the University of Chicago, where James Coumbe-Lilley, a former England Student international and RFL qualified Level 3 coach, is a lecturer. He is hoping to put RL coaching on the curriculum there and to develop student rugby league. Also in the area is Janet Keane, an RFL Level 2 coach interested in developing junior rugby league.

Meanwhile German Rugby League was boosted by the arrival of Andy Hay, ex Castleford and Leeds Rhinos player and subsequently on the coaching staff at Castleford and Salford. Since then, he has been development officer for Auckland RL in New Zealand. This wealth of experience will be hugely beneficial to the game in Germany and Andy is already working with Bob Doughton to develop both coaches and players there. Congratulations should also go to Michalis Chatziioannou in Greece who has become the second coach to complete the Level 2 qualification.

MATCH OFFICIALS MANAGER

Whilst the backdrop of Covid still drastically affected operations in the past 12 months, there were the green shoots of some progress in key areas of collaboration, planning and Match official performance.

In 2016, we set out a pathway to give individuals support from a technical education and a performance point of view. Whilst the past year may have been light on activity, it has shown real strength in how the pathway has worked for individuals who have been prepared to work with the system and follow the development process. It has shown that the system does work and with the improvements that we intend to make to the Technical Education Portal in 2022.



From a technical education perspective, two courses were delivered with the level one materials having received a comprehensive upgrade as part of the improvements that are being made to the technical education offering. What is more exciting is that these two courses were delivered by Erasmus + alumni who have both graduated via the ERL educator development system, which shows the progress we have made in taking fledging match officials and giving them a path in becoming and educator. Courses were delivered in Kenya and in Norway engaging 22 people in person, with online technical support being given on an ad-hoc basis. In the coming here, we will look to run 3 regional level 2 courses and develop a pathway for a Level 2 Educator.

The lack of formal online technical support has proved a challenge and as part of the updates required to the Technical Education portal this is something that has to be considered. However, we have been able to amass a fair amount of video in the last couple of years and we have been working closely with the coaching team to put together laws of the games quizzes which have allowed some level on interaction whilst physical training has not been possible.

From a performance perspective the first full tournaments were appointed via the IRL performance squads. Euro D saw officials from Greece, Czechia, Ireland and Spain travel to Turkey to officiate the games there, whilst Euro B in Serbia saw Serbian, Welch, French and Spanish officials taking to the field to officiate those games. Again, the majority of these individual officials had progressed through the Euro RL development pathway, coming into the performance group and officiating at the highest level possible. The officials used their time in camp to analyse their performances, which were then reviewed by the IRL Head of Match Officials with some good performance feedback. Elsewhere, on the performance pathway, several ERL educated officials officiated in mid-season test matches as the process for appointments and match sanctioned began to bear fruit in ensuring that the right official is appointed to the right game.

It has been a difficult year, but we can move forwards into the 2022 season with the confidence that the processes that we have put in place over the last 6 years work, and we can begin to work again with the individual nations in bringing forward the next generation of officials whilst working with those who are accredited to move them forward down a suitable pathway.

MEDIA MANAGER

Having, understandably, struggled for news and releases during lockdown in 2020, gradually stories began to emerge as playing seasons and competitions recommenced.

There was a conscious attempt to chart and document the various returns to play so that a journal of record for future generations would be established. In a similar vein, releases were also put out regarding the first steps in the Americas and MEA of self-determination with the setting up of steering groups in each region, important landmarks for illustrating the process.



Likewise, plans for women's and wheelchair competitions were highlighted, made even more relevant when the World Cups were postponed for a year, ERL coming out strongly in support of the organizing committee and their stance.

A spread of stories from across the various regions was maintained although there is still work to do to persuade nations that coordinated releases to amplify the message are preferential and more valuable than chasing contextual information once they have gone out. Clearly social media has a sense of immediacy, and some material is ideally suited to be dispersed directly by that method, but certain key stories still benefit in terms of wider exposure from a centralised formal release to specific media contacts and then bespoke follow up.

New nations playing, such as Slovakia, Belarus, El Salvador, Kenya and Montenegro, gained widespread interest, as did Serbia's four nations' tour around the Balkan region again illustrating that having the information as matches were completed ensured maximum impact, which was not always the case. Similarly, France bidding for the 2025 World Cup and updates on the process and progress were very warmly received.

The Euro B and D competitions were extremely well covered on the ground which enabled the information to be out there instantaneously, and provided an ideal template for tournament coverage.

Changes to the Board

SUB-COMMITTEES

The ERL administers four sub-committees, all of which operate independently of the plenary Board and reporting to it at the subsequent Board Meeting.

Dispute Resolution Committee

The DRC was created following a Board resolution taken at its 19 February 2016 Board Meeting. It is a standing committee of the ERL and is the first instance organ for Members to lodge formal grievance. The Committee is convened by order of the Board upon formal complaint being lodged in writing to the ERL General Manager or the Board and therefore there are no sitting members or fixed terms. The DRC was not required to be convened in 2021.

Financial, Audit and Risk Committee

The purpose of the FARC, constituted in February 2012, is to advise the Board on financial management, audit and risk management matters. In 2021 FARC was chaired by Brian Juliff, with Mahdi Choudhury as a sitting member. Robert Graham (RFL Finance Director) is a co-opted member with ERL General Manager David Butler and ERL Finance Manager Nigel Hansford in attendance.

Meetings are usually held approximately every six months. In addition, FARC also monitored the risk register in close consultation with the executive team.

FINANCIAL REPORT

- 1. This report covers the year to 31st December 2021
- 2. A net profit of £25,089 for the year is reported as compared to a loss of £82,081 for 2020 and a budgeted loss of £101k.
- 3. The Accounts have been reviewed by Haysmacintyre and they have reported that nothing has come to their attention that causes them to believe that the financial statements have not been prepared so as to give a true and fair view of the state of the Company's affairs as at 31 December 2021
- 4. Total revenues were £222k as compared to a budget of £202k. The main variance was that we received a £10k increased contribution from IRL than we had originally anticipated towards staffing costs.
- 5. Member fees were reintroduced in 2021 after a moratorium in 2020 as a result of the Covid pandemic.
- 6. Income from RFL was very close to what was planned (£34k).
- 7. Expenditure at £196k was much less than the Budgeted £303k as savings were made on Competition costs where there was only minimal technical education activity.
- 8. Savings in the Compliance & Delivery budget line were achieved principally from the absence of an 'in person' Congress. The management of expenditure has been good in the period with all costs keenly scrutinised and evaluated for value for money.
- 9. Net assets increased by the surplus in the year from £294k to £320k and are represented by £217k in bank balances; £112k EU Accrued income with debtors and creditors accounting for the difference. The EU balance has been carried forward once again and with the EU Project audit currently taking place it is hoped that the matter will be resolved in 2022. If we receive more than £112k the extra amount will be taken to profit in the year but conversely if we receive less than this then the write down would be taken as a loss in the current year income statement.
- 10. After a period of successful 'chasing', debts owed to ERL are much reduced with prepayments and accrued income combined down from £34k in 2020 to £13k in 2021.
- 11. Cash flow is satisfactory with combined balances of £217k at the year end and we are well placed to meet our obligations as they fall due.
